## SCHEDULE OF FEES

Rev. 3-14-2018

The fees described below are the minimum fees specific to the identified activities. Other fees may apply and will be added to the minimum fee. Plan Review and Application Fees are due at time of application. **All applicable fees must be paid prior to permit issuance.** 

Building permit fees are calculated based on valuations established in the Square Foot Construction Cost table published and updated periodically by the International Code Council. A current copy of this table is available from the Office of Planning and Community Development. Building-related projects that are not included in the table will be valued as follows:
